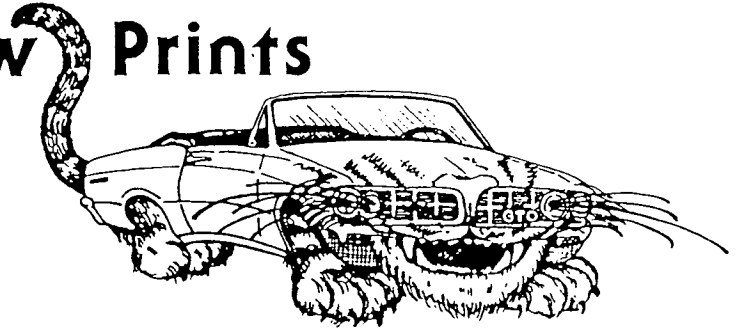

GTO ASSOCIATION OF CENTRAL OHIO

THE OFFICERS FOR THE GTO ASSOCIATION CENTRAL OHIO WILL CONSIST OF THE FOLLOWING: PRESIDENT, VICE PRESIDENT, TREASURER, SECRETARY, AND THREE DIRECTORS. THE FOLLOWING IS A LIST OF THE DESCRIPTIONS OF THESE OFFICES.

BOARD OF DIRECTORS

ALL OF THE OFFICERS OF THE CLUB WILL SERVE ON THE BOARD OF DIRECTORS ALONG WITH THREE ELECTED DIRECTORS. THIS BOARD WILL BE THE GOVERNING BODY FOR THE CLUB AND WILL MEET A MINIMUM OF 4 TIMES EACH YEAR. THE BOARD MEMBERS WILL REVIEW THE DIRECTION OF THE CLUB TO INSURE THAT IT IS COMPATIBLE WITH IT'S CONTINUED FUTURE. THE MEMBERS OF THE BOARD WILL REPRESENT THE CLUB MEMBERSHIP AT BOARD MEETINGS, AND BASE THEIR DECISIONS IN BOARD MEETINGS ON CLUB MEMBER'S INPUT. THE BOARD MEMBERS WILL VOTE ON ROUTINE ITEMS IN BOARD MEETINGS TO TAKE CARE OF THE RUNNING OF THE CLUB AND IT'S AGENDA. THE BOARD MEMBERS WILL ALSO FORMULATE PROPOSALS TO PRESENT TO THE CLUB RELATED TO CLUB FUNCTIONS AND ACTIVITIES. THE BOARD MEMBERS WILL ADVISE THE CLUB OFFICERS ON MATTERS RELATED TO THEIR JOB RESPONSIBILITIES, CLUB DECISIONS, AND IMPLEMENTATION OF CLUB GOALS. INFORMATION THE BOARD HAS GATHERED WILL BE PRESENTED TO THE CLUB MEMBERSHIP BEFORE MAJOR DECISION ARE VOTED ON IN CLUB MEETINGS ALONG WITH THE BOARDS RECOMMENDATIONS. THE BOARD WILL HAVE THE RESPONSIBILITY FOR THE REVIEW OF MONETARY EXPENDITURES RELATED TO CLUB FUNCTIONS. THE BOARD WILL ALSO REVIEW THE YEARLY FINANCIAL STATEMENT AND PRESENT THAT INFORMATION TO THE CLUB. IF A BOARD MEMBER IS UNABLE TO FULFILL THEIR TERM OF OFFICE IT WILL BE THE RESPONSIBILITY OF THE REMAINING BOARD MEMBERS TO REPLACE THAT INDIVIDUAL WITHIN 2 MONTHS PROVIDED THAT THE NOMINATED INDIVIDUAL RECEIVES A MAJORITY OF THE VOTES OF THE REMAINING BOARD MEMBERS. IF A BOARD MEMBER SHOULD NEED TO BE REMOVED FROM OFFICE FOR MISCONDUCT, IT WILL REQUIRE THE UNANIMOUS VOTE OF ALL THE OTHER BOARD MEMBERS. THE BOARD WILL THEN BE REQUIRED TO FILL THAT VACANCY WITH-IN TWO MONTHS.

PRESIDENT

THE PRESIDENT OF THE CLUB WILL BE ELECTED TO A ONE YEAR TERM OF OFFICE COMMENCING ON JANUARY 1st. THE PRESIDENT WILL SERVE ON THE BOARD OF DIRECTORS AND HAVE THE RESPONSIBILITY OF CHAIRING BOARD MEETINGS. THE PRESIDENT WILL ALSO CHAIR THE REGULAR CLUB MEETINGS AND MAKING SURE THESE MEETINGS RUN SMOOTHLY. THE PRESIDENT WILL SCHEDULE AT LEAST FOUR BOARD OF DIRECTORS MEETINGS AND MAY SCHEDULE MORE IF NECESSARY. IF THE PRESIDENT IS UNABLE TO ATTEND THE BOARD MEETINGS OR THE REGULAR MEETINGS, THE VICE-PRESIDENT OR OTHER PERSON APPOINTED BY THE PRESIDENT WILL CHAIR THE MEETINGS. THE PRESIDENT WILL KEEP THE BOARD OF DIRECTORS ADVISED AS TO THE DIRECTION OF THE CLUB, UPCOMING DISCUSSIONS, AND POTENTIAL PROBLEMS. THE PRESIDENT WILL PRESENT THE BOARDS VIEW TO THE CLUB MEMBERSHIP WHEN APPROPRIATE. THE PRESIDENT WILL APPOINT COMMITTEES, WITH THE BOARDS APPROVAL, WHEN NECESSARY TO UNDERTAKE TASKS FOR THE CLUB. THE PRESIDENT WILL HAVE THE AUTHORITY TO CO-SIGN CHECKS FOR THE PAYMENT OF CLUB BILLS AND ISSUE CORRESPONDENCE IN THE CLUBS NAME.

VICE PRESIDENT

THE VICE PRESIDENT WILL BE ELECTED TO A ONE YEAR TERM OF OFFICE COMMENCING ON JANUARY 1st. THE VICE-PRESIDENT WILL SERVE ON THE BOARD OF DIRECTORS FOR THE LENGTH OF THEIR TERM. THE VICE PRESIDENT WILL HAVE THE RESPONSIBILITY FOR FILLING IN FOR THE PRESIDENT AT MEETINGS THE PRESIDENT CANNOT ATTEND. THE VICE-PRESIDENT, ALONG WITH OTHER MEMBERS SELECTED, WILL HAVE THE RESPONSIBILITY TO POLL THE CLUB MEMBERSHIP ON KEY DECISIONS AND PRESENT THIS INFORMATION TO THE BOARD OF DIRECTORS AT BOARD MEETINGS AND THE CLUB AT CLUB MEETINGS. THE VICE-PRESIDENT WILL PRESENTS THE BOARD OF DIRECTORS VIEW, WHEN APPROPRIATE, TO THE CLUB MEMBERSHIP AT CLUB MEETINGS. THE VICE-PRESIDENT WILL ASSIST THE PRESIDENT AND OTHER OFFICERS, AS REQUESTED BY THE PRESIDENT AND PROVIDE GUIDANCE TO VARIOUS COMMITTEES AT THE BOARD'S REQUEST. THE VICE-PRESIDENT WILL HAVE THE AUTHORITY TO CO-SIGN CHECKS FOR THE PAYMENT OF CLUB BILLS.

TREASURER

THE TREASURER WILL BE ELECTED TO A ONE YEAR TERM OF OFFICE COMMENCING ON JANUARY 1st. THE TREASURER WILL ALSO SERVE ON THE BOARD OF DIRECTORS FOR THE LENGTH OF THEIR TERM. THE TREASURER WILL HAVE THE RESPONSIBILITY TO SEE THAT ALL BILLS ARE PAID IN A TIMELY MANNER, AND TO KEEP A RECORD OF ALL FINANCIAL TRANSACTIONS. THE TREASURER WILL REPORT REGULARLY ON THE FINANCES OF THE CLUB AND MAINTAIN A CURRENT FINANCIAL STATEMENT ON ALL THE ACCOUNTS OF THE CLUB. THIS INFORMATION WILL BE PROVIDED TO THE PRESIDENT, VICE PRESIDENT OR MEMBER OF THE BOARD OF DIRECTORS AT THEIR REQUEST. THE TREASURER WILL ALSO PRESENT FINANCIAL INFORMATION TO THE CLUB AT THE DIRECTION OF THE PRESIDENT. THE TREASURER WILL BE HAVE THE AUTHORITY TO ISSUE AND CO-SIGN CHECKS FOR THE PAYMENT OF CLUB BILLS. ALL CHECKS WILL NEED TO HAVE TWO SIGNATURES ON THEM FOR PAYMENT. THE TREASURER WILL BE RESPONSIBLE FOR THE RECEIPT AND HANDLING OF THE DUES RECEIVED FROM THE CLUB MEMBERSHIP ALONG WITH THE PROCEEDS FROM OTHER MONEY MAKING PROJECTS. THE TREASURER WILL ASSIST THE OTHER OFFICERS AND THE BOARD OF DIRECTORS AS NEEDED.

SECRETARY

THE SECRETARY WILL BE ELECTED TO A ONE YEAR TERM OF OFFICE COMMENCING ON JANUARY 1st. THE SECRETARY WILL ALSO SERVE ON THE BOARD OF DIRECTORS FOR THE LENGTH OF THEIR TERM. THE SECRETARY WILL BE RESPONSIBLE FOR MAINTAINING THE MINUTES OF THE CLUB MEETINGS AND SUBMITTING A SUMMARY OF THOSE MINUTES TO THE EDITOR IN A TIMELY MANNER. THE SECRETARY WILL HANDLE CLUB CORRESPONDENCE AS REQUESTED AND WILL MAINTAIN A FILE OF ALL CLUB CORRESPONDENCE FROM THE OFFICERS. THE SECRETARY WILL ALSO MAINTAIN THE FILES FOR THE CLUB ARCHIVES AND ADD TO THEM AS NECESSARY. THE SECRETARY

As you know, many cars are road tested daily in each and all assembly plants by Quality Control and Reliability personnel.

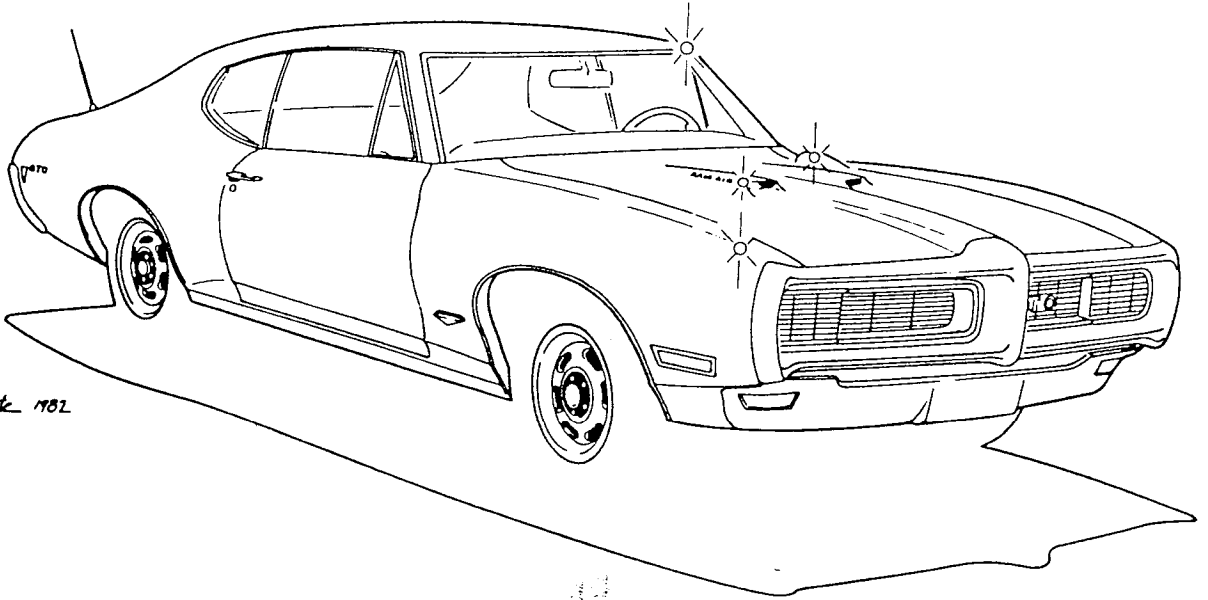
Usually, each car so evaluated will be driven less than 35 miles, but occasionally, one may be driven up to 100 miles. You will want to know that this mileage means that the car has been given a special Quality Audit Road Test. If any discrepancies were found, they were corrected and the quality of the car re-verified by Quality Control.

DO NOT ATTEMPT TO REMOVE SUCH "QUALITY TESTING MILES" FROM ANY ODOMETER BECAUSE ALL 1969 MODEL CARS ARE EQUIPPED WITH NEW "ANTI-REVERSING" ODOMETERS.

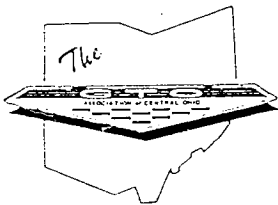

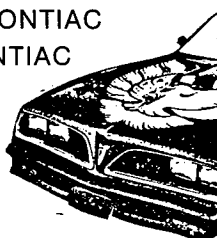
